Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), February 11, 2019 – In the framework of the liquidity contract (see press release dated 10 Decembre 2018), Ontex announces today that it has bought on Euronext Brussels **19,877** shares during the period between **February 04, 2019** and **February 08, 2019**. During the same period, Ontex has sold **26,645** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **3,582** on **February 08, 2019**. The total number of ordinary shares equals **82,347,218**.
