Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), February 10th, 2020 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **25,598** shares during the period between **February 3rd, 2020** and **February 7th, 2020**. During the same period, Ontex has sold **12,600** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **110,000** on **February 7th, 2020**. The total number of ordinary shares equals **82,347,218**.
