Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), April 15, 2019 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **40,459** shares during the period between **April 08, 2019** and **April 12, 2019**. During the same period, Ontex has sold **9,459** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **31,000** on **April 12, 2019**. The total number of ordinary shares equals **82,347,218**.
