Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), October, 19 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **61,224** shares during the period between October 12, 2020 and October 16, 2020. During the same period, Ontex has sold **55,724** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **9,500** on **October 16, 2020**. The total number of ordinary shares equals **82,347,218**.
