Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), October, 26 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **28,800** shares during the period between October 19, 2020 and October 23, 2020. During the same period, Ontex has sold **11,300** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **27,000** on **October 23, 2020**. The total number of ordinary shares equals **82,347,218**.
