Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), November, 23 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **76,158** shares during the period between November 16, 2020 and November 20, 2020. During the same period, Ontex has sold **73,058** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **31,600** on **November 20, 2020**. The total number of ordinary shares equals **82,347,218**.
