Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), February, 15 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **58,744** shares during the period between February 08, 2021 and February 12, 2021. During the same period, Ontex has sold **61,244** shares.
