Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), February, 22 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **62,410** shares during the period between February 15, 2021 and February 19, 2021. During the same period, Ontex has sold **49,910** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **82,500** on **February 19, 2021**. The total number of ordinary shares equals **82,347,218**.
