Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), March, 01 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **53,756** shares during the period between February 22, 2021 and February 26, 2021. During the same period, Ontex has sold **46,256** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **90,000** on **February 26, 2021**. The total number of ordinary shares equals **82,347,218**.
