## **Ontex repurchases own shares through its liquidity contract**

Aalst-Erembodegem (Belgium), July, 26 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **15,172** shares during the period between July 19, 2021 and July 23, 2021. During the same period, Ontex has sold **12,972** shares.
