Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), August, 30 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **13,232** shares during the period between August 23, 2021 and August 27, 2021. During the same period, Ontex has sold **25,232** shares.
