Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), September, 06 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **23,881** shares during the period between August 30, 2021 and September 03, 2021. During the same period, Ontex has sold **20,781** shares.
