Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), February, 07 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **43,801** shares during the period between January 31, 2022 and February 04, 2022. During the same period, Ontex has sold **97,389** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **2,412** on **February 04, 2022**. The total number of ordinary shares equals **82,347,218**.
