Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), April, 18 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **14,501** shares during the period between April 11, 2022 and April 14, 2022. During the same period, Ontex has sold **28,601** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **900** on **April 14, 2022**. The total number of ordinary shares equals **82,347,218**.
