Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), May, 16 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **56,028** shares during the period between May 09, 2022 and May 13, 2022.
