Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), June, 20 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **28,000** shares during the period between June 13, 2022 and June 17, 2022. During the same period, Ontex has sold **26,500** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **20,000** on **June 17, 2022**. The total number of ordinary shares equals **82,347,218**.
