Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), August, 22 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **39,554** shares during the period between August 15, 2022 and August 19, 2022. During the same period, Ontex has sold **21,554** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **18,000** on **August 19, 2022**. The total number of ordinary shares equals **82,347,218**.
