Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), September, 12 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **16,231** shares during the period between September 05, 2022 and September 09, 2022.
