Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), November, 21 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **25,789** shares during the period between November 14, 2022 and November 18, 2022. During the same period, Ontex has sold **24,289** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **9,500** on **November 18, 2022**. The total number of ordinary shares equals **82,347,218**.
