Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), January 16, 2023 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **29,963** shares during the period between January 09, 2023 and January 13, 2023.
