Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), January 23, 2023 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **28,767** shares during the period between January 16, 2023 and January 20, 2023. During the same period, Ontex has sold **22,223** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **17,544** on **January 20, 2023**. The total number of ordinary shares equals **82,347,218**.
