Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), February, 27 2023 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **38,285** shares during the period between February 20, 2023 and February 24, 2023. During the same period, Ontex has sold **38,785** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **8,500** on February 24, 2023. The total number of ordinary shares equals 82,347,218.
