Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), June 19 2023 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels 20,126 shares during the period between June 12, 2023 and June 16, 2023. During the same period, Ontex has sold 7,926 shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was 70,000 on June 16, 2023. The total number of ordinary shares equals 82,347,218.
