Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), October 23, 2023 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **13,785** shares during the period between October 16, 2023 and October 20, 2023. During the same period, Ontex has sold **15,785** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **30,000** on October 20, 2023. The total number of ordinary shares equals 82,347,218.
