



## Ontex repurchases own shares through its liquidity contract

Aalst, Belgium, June 14, 2024 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **19,333** shares during the period between June 10, 2024 and June 14, 2024. During the same period, Ontex has sold **15,133** shares.

The total number of own shares held by Ontex, pursuant to the liquidity contract, was **55,000** on June 14, 2024. The total number of ordinary shares equals 82,347,218.
